




Research Area - Hexagonale










Disposition Time and Clearance Rate

The disposition time and clearance rate of non-contentious proceedings allow a benchmarking to other countries / cases.






Access to Legal Services First Instance Courts






Population per NUTS-3 Region




Legal Expenditure Public Legal Expenditure relative to Public Total Expenditure

- The Hexagonale countries are distributed across almost the entire range;




Public and Private Legal Expenditure EU (2014, 2016 and 2018)



Conclusions and Policy Recommendations

- For succession proceedings the results show that the enhanced involvement of Notaries contributes to increase efficiency.
- Succession cases are a well-suited (first) candidate to increase the competences of Notaries. Any change should be regularly monitored to track and quantify the effects.
- Statistics of non-contentious proceedings are not available for individual topics on EU-level
- Include indicators for non-contentious proceedings in the statistics of the legal system of European countries.
- There are no cost-benefit analyses for the outsourcing of non-contentious proceedings available

> Conduct research projects on the European level to identify the upside of reforms with regard to welfare.
