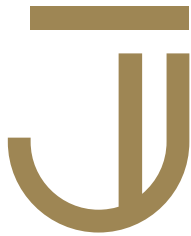

The EU co-financed JuWiLi project of the notarial chambers of Austria, Croatia, the Czech Republic, Slovakia and Slovenia, as well as with the participation of Hungary aims to analyse the term „court“ under the EU Succession Regulation in the context of non-contentious judicial procedures by notaries from a comparative law, fundamental rights, rule of law and economic viewpoint. The project includes perspectives for Slovenia where reflection on following the European trend of transferring court tasks to notaries is progressing. For better procedures and cross-border case-handling cooperation, a specialised online cooperation mechanism has been set-up through CNUE's ENN (European Notarial Network).

The event will focus on both the presentation of preliminary project results and the possible perspectives for Slovenia.

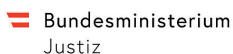
